EDISTO RECIPES



CROCK POT BBQ RIBS

4 pounds baby back ribs

Salt and pepper

Sauce

2 cups ketchup

1 cup chili sauce

½ cup brown sugar

¼ cup vinegar

2 tsp dried oregano

2 tsp Worcestershire sauce

Dash hot sauce

Preheat oven to 400°. Season ribs with salt and pepper to taste and place in a baking pan. Brown in oven on both sides approximately 15 minutes per side.

While ribs are browning, mix together all ingredients of sauce in a bowl big enough to add ribs to. Turn ribs to coat and place in crock pot on low for 6 to 8 hours or until ribs are tender. Enjoy!

Keyhole Sand Dollar

The velvet like skin of live keyhole sand dollars is usually tan, brown, grey or dark green. They are found in shallow seawater below tide lines, where they burrow into the seabed to obtain food. The creatures feed on fine particles of plankton and other organic matter they filter from the water.

They are so named because of the distinctive keyhole-shaped perforation toward the rear of the sand dollar. Look for them the next time you are on the beach.

March 8, 2018
REGULAR COUNCIL MEETING
6:00 P.M.

Present: Jane S. Darby, Mayor, Crawford Moore, Mayor Pro Tempore, Susan Hornsby, Jerome Kizer, and Patti Smyer, Council Members; *Quorum of Council Present.*

Councilwoman Smyer led those present in the Pledge of Allegiance and an Invocation.

Approval of Minutes

A. Regular Council Meeting Minutes, February 8, 2018 – Councilwoman Smyer moved to approve the regular Council meeting minutes of February 8, 2018, seconded by Councilwoman Hornsby and unanimously approved.

New Business

A. Resolution No. 2018-R06 Designating April 2018 as Fair Housing Month – Councilman Kizer moved to approve Resolution No. 2018-R06, which states in part, “The Town of Edisto Beach rejects discrimination on the basis of race, religion, color, sex, national origin, disability and/or familial status in the sale, rental or provision of other housing services.” Mayor Pro Tem Moore seconded the motion, which was approved unanimously.

B. First Reading of Ordinance No. 2018-07 To Amend Article III of Chapter 78 of the Code of Ordinances of the Town of Edisto Beach, entitled “Golf Carts” – Mayor Pro Tem Moore moved to approve the first reading of Ordinance No. 2018-07 to Amend Article III of Chapter 78 of the Code of Ordinances of the Town of Edisto Beach, entitled “Golf Carts.” This Ordinance amends the previous golf cart ordinance and clarifies some of the language in the previous Ordinance. Councilman Kizer seconded the motion, which was unanimously approved.

C. State and Subrecipient Public Assistance Funding Agreement, Hurricane Irma (FEMA-4346-DR-SC) – Mayor Pro Tem Moore moved to approve the State and Subrecipient Public Assistance Funding Agreement for Hurricane Irma (FEMA-4346-DR-SC). Councilwoman Hornsby seconded the motion which was approved unanimously.

D. Retreat Pool/Bathroom Variance – Mayor Darby asked those who would speak to the issue of the Retreat Pool/Bathroom Variance to stand. Patrick Brown, Building Code Administrator for the Town of Edisto Beach, and Mark Bailey, President of the Retreat of Edisto Association were administered an oath. The Mayor asked that the record please reflect that all witnesses were properly sworn and placed under oath to tell the truth. Mr. Bailey explained that the Retreat was in the beginning stages of building a new pool facility for the condominium complex located at 126 Jungle Road. The new pool facility will be closer to the buildings. Mr. Bailey explained that the bathrooms would be built similar to the restrooms at Bay Creek Park, of steel-reinforced concrete blocks, with storm vents that will allow storm surge to pass through. There will be a check valve on the sewer to keep sewage from mixing with storm water. Mayor Darby asked Patrick Brown if the requirements for wet floodproofing had been met by the owners of the Retreat. Mr. Brown stated, “The application as submitted has met the requirements for 14-241 (e) and (f).” Mr. Brown presented the Mayor with a copy of the application from the architect, which is attached to these minutes. Mayor Darby made a motion to approve the variance to allow wet floodproofing instead of dry floodproofing in a pool restroom at the Retreat with the condition, as assured by the Building Official, that all conditions have been met and that the old restrooms be removed as soon as the new restrooms are completed. Mayor Pro Tem Moore seconded the motion, which was unanimously approved.

Planning Commission

A. First Reading of Ordinance No. 2018-02, An Ordinance to Enact Article IX of the Town’s Zoning Ordinance Related to Fences on Private Lots – Councilwoman Hornsby moved to send the revised version of Ordinance No. 2018-02, An Ordinance to Enact Article IX of the Town’s Zoning Ordinance Related to Fences on Private Lots to the Planning Commission for review. Councilwoman Smyer seconded the motion, which was unanimously approved.

Departmental Reports and Committee Updates

Mayor Darby updated those in attendance on the Myrtle Street drainage and paving project. South Carolina Department of Transportation Secretary Christy Hall met with Mayor Darby and Administrator Hill in February. Secretary Hall

stated that the project will be let on May 1, 2018 and the Town would not bear additional costs. Mayor Darby also thanked Archie Johnston, Tommy Mann and Senator Cromer for their assistance in moving this project forward.

The lawsuit that has delayed the start of the Reverse Osmosis Plant has been withdrawn, and the project is moving forward.

House Bill #4683 has passed the House. This bill amends the setback jurisdictional line regulation, providing a different procedure for not only measurement but appeal.

Public Works

Public Works Director Bob Doub gave the report for the Public Works Department. In the Public Works Department, they replaced eight trash cans, continue regular maintenance of beach accesses and parks. They worked at Bay Creek Park to remove dead cypress trees and other vegetation, replaced broken slats on park benches and mowed and trimmed the park. The Public Works Department has been working on the bike path for the Edisto Road Race and cleared a drainage ditch from 3202 Myrtle Street to 3216 Myrtle Street.

An engineer will be coming to assist the Town in taking the water tank off line so repairs can be made.
