## EDISTO RECIPES



**Zucchini Bread**

3 cups all-purpose flour  
1 tsp salt  
1 tsp baking soda  
1 tsp baking powder  
1 Tbsp cinnamon  
3 eggs  
1 cup vegetable oil  
2 ½ cup sugar  
1 Tbsp vanilla extract  
2 cups grated zucchini  
1 cup chopped nuts

Makes 2-8x4 inch loaves. Grease and flour loaf pans and preheat oven to 325°. Sift dry ingredients together. Beat eggs, oil, vanilla and sugar together and add dry ingredients, mixing well. Stir in zucchini and nuts and pour batter into pans. Bake for approx. 50 minutes or until pick inserted in center comes out clean. Cool in pan on rack 20 minutes and then invert on rack and cool completely. Enjoy!

Mayor Darby called the meeting to order. Councilman Kizer led those in attendance in the Pledge of Allegiance and an invocation.

## Approval of Minutes

**A. Public Hearing Meeting Minutes, June 8, 2017** – Councilwoman Smyer moved to approve the minutes from the Public Hearing on June 8, 2017, seconded by Mayor Pro Tem Hornsby and approved unanimously.

**B. Regular Meeting Minutes, June 8, 2017** – Mayor Pro Tem Hornsby moved to approve the minutes from the Regular Meeting held on June 8, 2017, seconded by Councilman Moore and unanimously approved.

## Proclamation and Presentations

**A. Proclamation No. 2017-P19 in Honor of the 100<sup>th</sup> Birthday of Colonel B. N. (Ben) Skardon** – Councilman Moore moved to approve Proclamation No. 2017-P19 in Honor of Colonel Ben Skardon’s 100<sup>th</sup> Birthday. Councilman Kizer seconded the motion, which was approved unanimously.

## Old Business

**A. Myrtle/Fort Street Debris Pick-up** – This item was tabled at the May 11, 2017 Council meeting until additional information was obtained. The Town was tasked with observing the area before and during yard debris collection. The Town has not observed any areas obstructed by yard debris during this period. Councilwoman Smyer moved to dismiss this item since there has been no evidence of a problem, seconded by Mayor Pro Tem Hornsby and approved 4 – 1 with Mayor Darby dissenting.

## New Business/Apearances

**A. Memorandum of Agreement for the Provision of Secure Detention Services with the Department of Juvenile Justice Detention Center for Fiscal Year 2017-18** – Councilman Moore moved to approve the memorandum of agreement at a per diem cost of \$50.00 per day and authorized the Town Administrator to execute said agreement. Mayor Pro Tem Hornsby seconded the motion, which was unanimously approved.

## **MINUTES** **July 13, 2017** **REGULAR COUNCIL MEETING** **6:00 P.M.**

**B. First Reading of Ordinance No. 2017-21 to Amend Section 8-32 and Section 8-34 of the Town's Code** – Councilman Kizer moved to approve the first reading of Ordinance No. 2017-21 to amend Section 8-32 and Section 8-34 of the Town's Code as it relates to prohibitions and alcoholic beverages in Bay Creek Park. Mayor Pro Tem Hornsby seconded the motion, which was approved unanimously.

**C. Emergency Purchase Order - \$4,100 Air Conditioner, Town-owned Apartment** – Councilwoman Smyer moved to approve the emergency purchase order in the amount of \$4,100 for an air conditioner due to the air conditioning in the town-owned apartment malfunctioning. Councilman Moore seconded the motion. Funds were taken from Building Maintenance. The motion was unanimously approved.

**D. Emergency Purchase Order - \$13,913 – Booster Pump No. 1** – Councilman Moore moved to approve the emergency purchase order for \$13,913, to be paid from utilities renewal and replacement to A.C. Shultes of Carolina, Inc. for Booster Pump No. 1. Councilman Kizer seconded the motion, which was approved unanimously.

**E. Emergency Purchase Order - \$31,900 – Civic Center Air Conditioners** – The air conditioner unit stopped functioning in the Edisto Room at the Civic Center and could not be repaired. The cost to replace this unit was \$7,500. Since all of the units were original units requiring periodic repair and two units failed last year, the Town obtained verbal quotes and replaced all the units and installed wi-fi thermostats making it easier to adjust temperatures for events. The Town achieved a cost savings by replacing several units at a time. Councilwoman Smyer moved to approve the emergency purchase order for \$31,900 to replace the air conditioners at the Civic Center, from Civic Center funds, seconded by Mayor Pro Tem Hornsby and unanimously approved.

**F. 2017 Shrimp Fest** – Last year, Town Council provided a \$2,500 sponsorship for this event. It is the Town's understanding that even with other sponsorships, this event only netted \$900.00. Councilman Moore moved to terminate the Shrimp Fest, with the stipulation that the Edisto Chamber of Commerce aggressively pursue replacing it with something that would create more traffic. Councilwoman Smyer stated she had spoken with an Edisto business owner, and that person said they had lost money since they had to close their business to come work the Shrimp Fest. The

motion was seconded by Councilman Kizer and approved 4 – 0. Mayor Pro Tem Hornsby recused herself since she is a vendor at the Shrimp Fest.

**G. November Council Work Session** – The November work session falls on election day and November 8 is the South Carolina Beach Advocates annual meeting. Mayor Pro Tem Hornsby made the motion to approve moving the November Council Work Session from November 8, 2017 to Monday, November 6, 2017. Council requests that they receive their informational packets on the Thursday prior to the meeting. Councilman Moore seconded the motion, which was approved unanimously.

**H. Town of Edisto Beach Post Issuance Compliance Policies and Procedures** – Councilman Kizer moved to approve the Post Issuance Compliance Policies and Procedures as it relates to the Combined Water and Sewer System Revenue Bonds. Councilwoman Smyer seconded the motion, which was unanimously approved.

**I. First Reading of Ordinance No. 2017-20 to Amend Chapter 10 of the Town's Code of Ordinances to add Section 10-41 Related to Nudity and Display of Specified Anatomical Areas on the Beach and Within Certain Areas of the Town** – There are situations (mostly juvenile antics) that if the Town charged offenders according to state law, if convicted, the offender would be required to register as a sexual offender and face a three-year prison term. Councilwoman Smyer moved to approve the first reading of Ordinance No. 2017-20 to Amend Chapter 10 of the Town's Code of Ordinances to add Section 10-41 Related to Nudity and Display of Specified Anatomical Areas on the Beach and Within Certain Areas of the Town. Councilman Kizer seconded the motion, which was approved unanimously.

**J. Special Event Application – Bay Creek Investments LLC – Edisto Beach Shag Festival** – Councilwoman Smyer moved to approve the special event application for the Edisto Beach Shag Festival to be held on September 1 – 3, 2017 at Bay Creek Park from 11:00 a.m. – 11:00 p.m. Friday and Saturday, and 12:00 p.m. – 8:00 p.m. on Sunday. Councilman Kizer seconded the motion, which was unanimously approved.

**K. Edisto Beach Shag Festival Sponsorship** – Councilman Moore moved to approve the request from Darrin Moore for \$6,000 and to waive the fees for the rental of Bay Creek Park. Funds of \$14,859 are available in the Alcohol Permitting Fund. Mayor Pro Tem Hornsby seconded the

motion. During discussion, Mayor Darby asked that Mr. Moore work with Administrator Hill on the garbage can/dumpster issue. The motion was approved unanimously.

**L. Amend American Engineering Work Authorization No. 7** - During the Bond Issuance process, the underwriters asked for additional information that expanded the original scope of work. The original project cost was \$4,700. Councilman Kizer moved to approve amending the Work Authorization by \$4,200 for a new total of \$8,900 to be paid from the bond funds. Mayor Pro Tem Hornsby seconded the motion, which was unanimously approved.

**M. Change Order No. 3, Crowder Construction Company** – Crowder Construction Company has completed the groin lengthening project. According to the total quantities, Crowder Construction placed an additional 77 tons of stone at a cost of \$6,930. Councilman Moore moved to approve Change Order No. 3 for \$6,930 increasing the project total from \$5,410,500 to \$5,417,430. Councilwoman Smyer seconded the motion, which was approved unanimously.

**N. Wharton Smith Phase 2** – Councilwoman Smyer moved to approve to allow the Town Administrator and Mayor with the assistance of legal counsel to negotiate the Phase 2 Agreement and authorize the Mayor to execute the negotiated Phase 2 agreement for the Water Improvement Project. Councilman Moore seconded the motion which was unanimously approved.

**O. TIDE Committee Recommendations** – Councilman Kizer moved to defer until the October agenda the recommendations of the TIDE Committee which are as follows: Motion 1 – the TIDE Committee unanimously recommends to Council to open up immediately every access that has ability for off-street parking, especially #1A, 2, 5, 6 and 20 and re-visit at the end of the season for evaluation. Motion 2: The TIDE Committee unanimously recommends Council blade and clean up access #29 at this time for the safety of pedestrians, with review by the committee in the fall for evaluation of modifications including landscaping. Councilman Moore seconded the motion. Mayor Pro Tem Hornsby asked the TIDE Committee to prioritize the accesses in the first motion. Councilwoman Smyer stated that she has looked at beach access 29 and deems it safe and usable by pedestrians. Mayor Darby said if an issue comes up between now and October, there is a possibility of blading a path at that access for safety. Mayor Darby called for the vote and the motion was approved unanimously.

**Committee Vacancies**

**A. ATAX Board – 2 vacancies** - Stephanie Jumper and Van Maxwell have reapplied for terms on the Accommodations Tax Advisory Board. Councilwoman Smyer moved to accept the two applications for the ATAX Board, seconded by Mayor Pro Tem Hornsby and unanimously approved.

**B. Zoning Board of Appeals – 3 vacancies** - The terms of Polly McIntosh, Charles Boozer and Joe Dreher expire on September 1, 2017. Joe Dreher is the only member eligible to serve another term. Councilman Moore moved to approve the advertising of these vacancies. Councilman Kizer seconded the motion which was approved unanimously.

**Departmental Reports and Committee Updates**

Administration

Administrator Hill read two letters from Edisto property owners, one from Jennifer Jones commending Patrick Brown and thanking him for all his help during Hurricane Matthew clean up and recovery, and one from Mr. and Mrs. Goodman thanking the Fire Department and the Police Department for its timely response to a house struck by lighting across the street from their property.

Iris Hill, Town Administrator gave the report for June 2017.

Chief Brothers reported interesting statistics comparing Folly Beach, who just had license reader cameras installed, to Edisto Beach. From

June 2 – July 11, Edisto had 12.6% more traffic coming in than Folly Beach. The week of June 30 – July 4, Edisto had 37.4% more incoming traffic than Folly Beach. The weekend of July 7, Edisto Beach had 40.9% more incoming traffic than Folly Beach. Mayor Darby asked Chief Brothers to begin looking at what kind of problems this added traffic is causing.

### **Public Comment**

Fielding Foreman, who lives on Fort Street, addressed Council to talk about the traffic, yard debris and garbage cans that have been blocking the street. The houses that front on Myrtle are using Fort Street for their garbage and yard debris collection, which causes a lot of congestion in the small street. Mr. Foreman said that on July 4<sup>th</sup> of this year the street was nearly impassable. Mr. Foreman asked Council to rethink the Fort Street situation and address it again at a later date.

Councilman Moore moved to adjourn the meeting, seconded by Councilman Kizer and unanimously approved.
