EDISTO RECIPES

Stuffed Strawberries



1 pint fresh strawberries
1 8oz pkg cream cheese
½ cup confectioners' sugar
(optional) orange flavored liqueur to taste

Stand strawberries upright on stem side (you may have to trim them some to get them to stand on their own). Make a slit approximately $\frac{3}{4}$ of the way down from the tip towards the.

December 14, 2017

Present: Jane S. Darby, Mayor, Crawford Moore, Mayor Pro Tempore, Susan Hornsby, Jerome Kizer, and Patti Smyer, Council Members; *Quorum of Council Present.*

Mayor Darby called the meeting to order and Councilman Kizer led those present in the Pledge of Allegiance and an invocation.

Approval of Minutes

A. Public Hearing Minutes, November 9, 2017 – Councilwoman Smyer moved to approve the minutes from the Public Hearing held on November 9, 2017, seconded by Councilwoman Hornsby and approved unanimously.

B. Regular Council Meeting Minutes, November 9, 2017 – Mayor Pro Tem Moore moved to approve the minutes from the regular Council meeting held on November 9, 2017, seconded by Councilman Kizer and unanimously approved.

Proclamations and Presentations

A. Recognition of Police Chief George Brothers for Lifetime Achievement Award –

This award recognizes the long-term accomplishments and contributions of an individual that has earned the respect of the law enforcement community in South Carolina. The award was developed to honor those who have served the law enforcement and public safety professions generously and unselfishly for at least twenty-five continuous years. It is to commemorate exemplary talents and contributions as demonstrated by the nominee's dedication, loyalty, ability and integrity. This award is intended to recognize those individuals that have made outstanding contributions to the South Carolina Law Enforcement Officers' Association. Congratulations to Edisto Beach Chief of Police George Brothers on this prestigious award.

B. Recognition of Utilities Director Bob Doub for System Manager of the Year –

Each year the South Carolina Rural Water Association presents awards to those who have excelled in their fields. This year, Bob Doub was recognized as System Manager of the Year. Congratulations to Mr. Doub on a well-deserved honor.

C. Presentation from SCE&G on Tree Trimming –

Information was presented on Tuesday at the Council worksession regarding safety, reliability, proper pruning methods, and impacted areas dealing with trimming trees. SCE&G has started trimming trees at the McKinley Washington Bridge and will make their way to Edisto Beach in January. Further information can be obtained from the Municipal Clerk.

New Business

A. Fiscal Year Audit Ending June 30, 2017 –

Eve McCoy presented the audit for the year ending June 30, 2017. Ms. McCoy stated, "I have expressed my opinion, and it is a 'clean' opinion or an 'unqualified' opinion, and it is the highest level of assurance an auditor can give." The water and sewer fund has a change in net position of \$129,600. The Town's bond covenants require the Town make a certain level of income in the water and sewer fund in order to comply, which was achieved. In the general fund, which accounts for the day-to-day operations of the town, revenues exceeded expenditures by \$458,647. Ms. McCoy then explained, "Anytime anyone receives federal dollars, in excess of \$750,000, you're required to have additional procedures performed and of course, in this case, you got all that FEMA money,

certainly in excess of \$750,000." All federal rules and regulations regarding these procedures have been followed. Ms. McCoy pointed out that FEMA could audit the Town's records independently up to six years after the event. The Town is required to complete and file a copy of the 'data collection form' with the National Single Audit Clearinghouse, which has been done. Ms. McCoy closed by thanking the Town for its hard work and stating, "Overall I think you have an excellent audit report." Mayor Darby echoed Ms. McCoy's sentiments and commended the administrative staff.

B. Memorandum of Understanding – Edisto Art Guild –

Councilwoman Smyer moved to approve the Memorandum of Understanding between the Edisto Art Guild and the Town of Edisto Beach for the use of the Civic Center. Mayor Pro Tem Moore seconded the motion, which was unanimously approved.

C. First Reading of Ordinance No. 2017-34 to Amend Article IV of Edisto Beach Code of Ordinances to Enact Section 14-117 Related to Severability –

Councilman Kizer moved to approve the First Reading of Ordinance No. 2017-34 to Amend Article IV of Edisto Beach Code of Ordinances to Enact Section 14-117 Related to Severability. This is the last amendment request from SCDNR to meet the State Model Flood Ordinance. Councilwoman Smyer seconded the motion, which was approved unanimously.

D. Commercial Sub-lease Agreement With Subordination among Colleton County, the Episcopal Church on Edisto, Inc. and the Town of Edisto Beach –

Mayor Pro Tem Moore moved to approve the Commercial Sub-lease with Subordination for the Episcopal Church on Edisto, Inc. to use the Bay Creek Room at the Civic Center. Councilman Kizer seconded the motion, which was unanimously approved.

E. Commercial Sub-lease Agreement With Subordination among Colleton County, the Edisto Art Guild and the Town of Edisto Beach –

Councilwoman Hornsby moved to approve the Commercial Sub-lease with Subordination for the Edisto Art Guild to use the Hammocks room at the Civic Center. Councilman Kizer seconded the motion which was approved unanimously.

F. Statewide Mutual Aid Agreement for Emergency and Disaster Response/Recovery –

Councilwoman Smyer moved to approve the Statewide Mutual Aid Agreement and to have the Mayor execute said agreement. Councilwoman

Hornsby seconded the motion, which was unanimously approved.

G. Award of RFP 2017-15 SUV 4x2 Intermediate Utility Vehicle – Councilwoman Smyer moved to approve the award of RFP 2017-15 to Walterboro Ford for an SUV 4x2 Intermediate Utility Vehicle with added safety features. Councilman Kizer seconded the motion, which was approved unanimously.

H. Proposal for Asbestos and Lead Based Paint Assessment, 3002 Lee Street – Mayor Pro Tem Moore moved to approve the agreement with S&ME, Inc. for an assessment to determine if asbestos and/or lead based paint is present in the property located at 3002 Lee Street, and to authorize the Town Administrator to execute said agreement. Councilwoman Hornsby seconded the motion, which was approved unanimously.

I. Proposal for Asbestos and Lead Based Paint Assessment, Tract M Wellhouse – Mayor Pro Tem Moore moved to approve the agreement with S&ME, Inc. for an assessment to determine if asbestos and/or lead based paint is present in the town-owned property located at the Tract M Wellhouse, and for the Town Administrator to execute said agreement. Councilman Kizer seconded the motion which was unanimously approved.

J. Resolution No. 2017-R35 Approving the Mutual Aid Agreement Between Charleston County Sheriff’s Office and the Town of Edisto Beach – Councilwoman Hornsby moved to approve the resolution between the Charleston County Sheriff’s Office and the Town of Edisto Beach and to have the Police Chief execute said agreement. Councilwoman Smyer seconded the motion, which was approved unanimously.

K. Delegation Dinner – Councilman Kizer moved to approve the Town of Edisto Beach joining with the City of Walterboro in hosting a dinner for the Colleton Legislative Delegation in Columbia at the annual legislative meeting. Mayor Pro Tem Moore seconded the motion, which was unanimously approved.

L. Rescheduling of the February 6, 2018 Council Worksession – Councilwoman Smyer moved to approve changing the worksession scheduled for Tuesday, February 6, 2018 to Monday, February 5, 2018 due to the conflict with the Municipal Association’s Legislative Hometown Action Day.

Departmental Reports and Committee Updates

Mayor Darby welcomed Al Jenkins from Senator Tim Scott’s office. Mr. Jenkins has been serving as a liaison between Senator Scott and the Town on the Myrtle Street drainage project.

Administration

Town Administrator Iris Hill gave the report for the month of November 2017. She began by complimenting the staff and department heads, three of whom were recognized by their peers as top managers in their field and others who serve on various boards. Mayor Darby added her commendation to the Town Administrator who serves on the Board for the Beach Advocates. Administrator Hill went on to thank Maxine Burton, Financial/Budget Analyst for her diligence making sure the Town’s audit goes as smoothly as possible.
