Ken Kerber, Superintendent **State Fire Academy Graduates 23 in February**

The South Carolina Department of Labor, Licensing and Regulation's South Carolina Fire Academy graduated 23 recruits, Friday, Feb. 26, 2016, from its eight-week firefighter candidate school in Columbia. Keynote speaker was Chief Matthew McDowell, City of North Charleston Fire Department.

The firefighters from 15 fire departments across the state, and one out-of-country department, underwent a 320-hour training program of classroom and hands-on firefighting skills development.

The in-depth training, offered quarterly at the Fire Academy, includes emergency responder first aid training, hazardous materials operations training, auto extrication, flammable liquids and gas firefighting, rescue training, and National Fire Protection Association (NFPA) Firefighter I and Firefighter II levels.

"This is a very challenging program that requires team work, in-depth study, extensive hands-on training with live fires, eight practical skills evaluations and seven written tests to meet the National Fire Protection Association standards," Fire Academy Branch Chief Lenny Busby said. "I am pleased with the recruits and our staff; they have shown extreme commitment to service by completing this challenging and comprehensive program. Our state and their communities will be better served as a result of their efforts."

GARBAGE PICK-UP

Twice weekly (Monday and Friday) garbage service will resume April 4th.



If you have opted out of the roll-out/back service, garbage containers must be placed at the curbside no earlier than the day before the morning of pick-up. Carts must be rolled back to your house within 12 hours after pick-up.

Yard debris will continue to be picked up on Tuesday. Yard debris is defined as material resulting from **normal and routine yard maintenance**. Normal and routine yard maintenance means mowing and raking, shrubbery prunings, pick-up of fallen limbs and fronds, and other activities related to the routine and ongoing maintenance of lawn and associated shrubbery. The term **does not** include tree cuttings or pruning. Contractors are required to remove yard debris unless it is a result of normal and routine maintenance. Yard debris shall be placed in neat piles at curbside adjacent to owner’s property or at the property line nearest the street with the following limitations:

- a. Materials are not to be placed on an adjoining lot whether vacant or otherwise.
- b. Leaves, pine straw, pampas and grass clippings, small shrubbery clippings, etc., must be placed in sturdy bags or other suitable containers. Such loose material placed at the curb will not be collected.
- c. Brush, limbs, and shrubbery trimmings shall:
 1. Be no more than six inches in diameter.
 2. Be no more than five feet in length with all small limbs trimmed from larger limbs.
 3. Weigh no more than 30 pounds each.

EDISTO RECIPES



CORN PUDDING

2 Cups corn or one can, drained
4 eggs, separated
½ stick butter, melted
1 cup milk
1 tsp salt
¼ tsp pepper

Mix corn, milk, butter and yolks of eggs along with salt and pepper. Beat egg whites (not too stiff) and fold into rest of mixture. Put in greased casserole dish and place dish into pan with about ½ inch warm water in bottom of pan. Bake at 300° for 40 to 50 minutes or until brown on top.

MINUTES **February 11, 2016** **REGULAR COUNCIL MEETING** **6:00 P.M.**

Present: Jane S. Darby, Mayor, Susan Hornsby, Mayor Pro Tempore, Jerome Kizer, Crawford Moore, and Patti Smyer, Council Members;
Quorum of Council Present.

Mayor Darby called the meeting to order, followed by the prayer and Pledge of Allegiance led by Councilman Moore.

Approval of Minutes

Councilman Moore moved to approve the Town Council minutes of January 14, 2016, seconded by Mayor Pro Tem Hornsby. The motion passed unanimously.

Proclamations and Presentations

Mayor Darby presented Building Codes Official Patrick Brown with a certificate acknowledging ten years of service. Mayor Darby announced that at the worksession, Margaret Green had been presented with a Starfish Award for her work in obtaining a grant from the South Carolina

Department of Environmental Control and the Office of Ocean and Coastal Resource Management Coastal Access Improvement Funds. The grant will allow the Town to upgrade two beach accesses.

New Business/Apearances

A. FY 2015-2016 Six-Month Budget Adjustment – Mayor Pro Tem Hornsby moved to approve the following annual six month budget adjustments to the FY 2015-2016 budget that will result in a \$12,068 increase in the general fund contingency funds (\$90,398); a \$2,470 reduction in the water contingency funds (\$123,905 balance); and a \$1,550 reduction in sewer contingency funds (\$56,009 balance), and to approve changes to the alcohol temporary permitting fund, sewer R & R and water R & R. The adjustment includes a 2% cost of living increase for all employees. Councilman Kizer seconded the motion, which was unanimously approved.

B. FY 2016-2017 Budget Calendar – Councilwoman Smyer moved to approve the FY2016-2017 budget calendar, seconded by Councilman Kizer and approved unanimously.

C. Special Event Application Road Race Calendar – Councilman Kizer moved to approve the special event application from the Edisto Chamber for the Edisto Road Race to be held on Saturday, March 19, 2016, from 8:00 a.m. to 11:00 a.m. and close the following roads during the race: Jenkins Street to Myrtle Street and Myrtle Street from Jenkins Street to Lybrand Street. Councilman Moore seconded the motion, which was unanimously approved.

D. Marine Response Standard Operating Procedures Amendment – Councilman Moore moved to approve an amendment to the Marine Response Standard Operating Procedures to provide for use of the drive-on dock at Bay Creek Park by DNR and other state agencies and also response for mutual aid. The motion was seconded by Mayor Pro Tem Hornsby and approved unanimously.

E. Civic Center – Chamber Request to Waive Fees – Councilwoman Smyer moved to approve the Edisto Chamber's request to Council to waive the rental fee for the Civic Center and hold a job fair on April 8, 2016, from 10:00 a.m. until 3:00 p.m. Councilman Moore seconded the motion which was unanimously approved.

F. Consent Order #15-027-WP to State Land Application Permit ND0063789 – Town

Administrator Iris Hill and Utilities Director Bob Doub gave a PowerPoint presentation attached to these minutes explaining the workings of the Waste Water Treatment Plant, the Notice of Violation and the Consent Order. After the presentation, Councilman Moore asked what the maximum was on the Biological Oxygen Demand (BOD). Mr. Doub told him thirty was the limit. Bob Sandifer asked if the influent (in) is being tested, since that seems to be the only thing that changed. Mr. Doub said that the influent is being tested, as is the effluent (out). No harmful chemicals that could be killing the bacteria were found. Administrator Hill stated that the lab found that a sufficient number of good bacteria was absent in cell #1. The lab wants to continue testing the influent over time. Councilman Moore asked if there could be another fine. Mr. Doub said if the Town is under Consent Order and working to resolve the problem there would not be a fine. Councilwoman Smyer asked if the BOD problem was because the plant was too small. Mr. Doub said our WWTP was permitted for 350,000 gallons per day and is currently operating at below 60,000 gallons per day. Tommy Mann asked if the influent was routinely monitored. Mr. Doub said that the Town had been testing influent over the last six months, even though the plant was not required to monitor influent. Mr. Mann asked how much sludge was in the plant as a result of the bacteria being low in cell #1. Mr. Doub stated that it was not bad. Three different tests have been done and found there are levels of five to six feet. Jim Matthews of OnLine Environmental brought a sonar device to check sludge levels and found that the sludge levels were declining.

G. First Reading of Ordinance 2016-04 to Amend Section 82-1 of the Town's Code of Ordinances to Enact Subsections (d), (e), (f) and (g) – Councilwoman Smyer moved to approve the first reading of Ordinance 2016-04 to amend Section 82-1 of the Town's Code of Ordinances to enact subsections (d), (e), (f) and (g) dealing with fees and charges. This establishes a fee for testing of the water meter, meter relocation, after hours calls for service and water testing. Councilman Kizer seconded the motion which was approved unanimously.

H. Intergovernmental Agreement Between Charleston County and the Town of Edisto Beach for Litter Control on Highway 174 – Councilwoman Smyer moved to approve the agreement to provide litter control on Highway 174 and have the Mayor execute said agreement. Charleston County will provide municipal aid to Edisto Beach to cover the costs of this project. Charleston County will provide \$18,000 for 2015-

2016 and additional funding annually, based on the actual cost. Councilman Moore seconded the motion which was unanimously approved.

I. Resolution 2016-R03 calling for the Colleton County Legislative Delegation's Support of Governor Nikki Haley's \$40,000,000 Funding for Beach Nourishment

- Councilman Kizer moved to approve Resolution 2016-R03 calling for the Colleton County Legislative Delegation's Support of Governor Haley's \$40,000,000 Funding for Beach Nourishment. Councilwoman Smyer seconded the motion which was approved unanimously.

J. RFP 2016-03 Bike Path Dock Site Award

– Mayor Pro Tem Hornsby moved to approve awarding the bid for RFP 2016-03 for the bike path on Dock Site Road to Smoak Construction, at a cost not to exceed \$20,975. The Federal Emergency Management Agency has paid 75% (\$15,731.25). The Town's match is 25% (\$5,243.75). The Town's match will come from the Local Accommodations Fund. Councilman Moore seconded the motion, which was unanimously approved.

K. RFP 2015-05 Water and Wastewater Professional Engineering Services

– Councilman Moore moved to approve award of RFP 2015-05 Water and Wastewater Professional Services to Thomas & Hutton and authorize the Town Administrator to negotiate and execute said Master Consulting Agreement for a period of three years with two 2-year extensions. The Water and Sewer Committee met on January 27, 2016, and unanimously recommended this award. Councilman Kizer seconded the motion, which was approved unanimously.

L. Resolution 2016-R05 calling for the Colleton County Legislative Delegation's Support of Governor Nikki Haley's Full Funding of the Local Government Fund

– Mayor Pro Tem Hornsby moved to approve Resolution 2016-05 calling for the Colleton County Legislative Delegation's support of Governor Nikki Haley's full funding of the Local Government Fund. Councilman Moore seconded the motion, which was unanimously approved.

M. Resolution 2016-R06 To Request the Tourism Expenditure Review Committee (TERC) Grant Permission to the Town of Edisto Beach to Use State Accommodations Tax Funds Acquired in Excess of Two Years Prior for Beach Renourishment

– Mayor Pro Tem Hornsby moved to approve Resolution 2016-R06 asking the TERC grant permission to the Town

to use State Accommodations Tax funds acquired in excess of two years prior for beach renourishment. Councilwoman Smyer seconded the motion, which was approved unanimously.

N. Correct Scrivener’s Error Item E. Jungle Shores Water Line Extension Project Change Order No. 1, November 12, 2015 – Councilman Moore moved to approve the correction of the scrivener’s error on Item E, Jungle Shores Water Line Extension Project Change Order Number 1. Change Order No. 1 should have been Change Order No. 2. Change Order number 1 was included in the original contract documents and did not result in any monetary change. Council approved up to \$30,000 because the cost of Change Order No. 2 was unknown at the time. The actual cost was \$26,000, resulting in a \$4,000 difference. Councilman Kizer seconded the motion which was unanimously approved.

O. Special Event Application – Edisto Belles Beach Walk – Councilwoman Smyer moved to approve the Edisto Belles Beachwalk on May 21, 2016, from 9:00 a.m. until noon. The walk will begin at 603 Palmetto Boulevard at the registration/check-in station; continue on the beach from Beach Access 6 to Beach Access 24 and back to Beach Access 6. Mayor Pro Tem Hornsby seconded the motion, which was unanimously approved.

Committee Vacancies

A. TIDE Committee – Susan Kozub submitted her resignation from The Image and Design of Edisto Committee. Councilwoman Smyer moved to approve advertising the vacancy, seconded by Councilman Moore and approved unanimously.

B. Water and Sewer Committee – David Whitten resigned from the Water and Sewer Committee. Councilman Moore moved to approve advertising the vacancy, seconded by Mayor Pro Tem Hornsby and unanimously approved.

Planning Commission

A. 1706 Palmetto Boulevard Lot Line Adjustment – Councilman Kizer moved to approve the request of Lee Frank on behalf of Debra A. Domeck to combine Lot 3, Block BB with a strip of land in front of the property that extends to the Mean High Water Mark for the purpose of creating one unified lot. This is requested to improve the setback conditions for septic systems and potential improvements related to a new house that Ms. Domeck is considering building. Councilman Moore seconded the motion, which was approved unanimously.

Departmental Reports and Committee Updates

Mayor Darby announced the Republican Presidential Primary will be held on Saturday, February 20, 2016, from 7:00 a.m. – 7:00 p.m. at Town Hall. The Democratic Presidential Primary will be held on Saturday, February 27, 2016, from 7:00 a.m. – 7:00 p.m. at Town Hall. Registered voters may vote in one of the two primaries, but not both.

Mayor Darby read a letter of thanks and appreciation from Marguerite Dearth to the Fire Department for assistance when she was injured while vacationing on Edisto.

On March 29 from 4:00 – 7:00 p.m. there will be a hearing on the new flood maps and flood designation at the Civic Center.
