## GARBAGE PICK-UP

Twice weekly (Monday and Friday) garbage service will resume April 4<sup>th</sup>.



If you have opted out of the roll-out/back service, garbage containers must be placed at the curbside no earlier than the day before the morning of pick-up. Carts must be rolled back to your house within 12 hours after pick-up.

Yard debris will continue to be picked up on Tuesday. Yard debris is defined as material resulting from **normal and routine yard maintenance**. Normal and routine yard maintenance means mowing and raking, shrubbery prunings, pick-up of fallen limbs and fronds, and other activities related to the routine and ongoing maintenance of lawn and associated shrubbery. The term **does not** include tree cuttings or pruning. Contractors are required to remove yard debris unless it is a result of normal and routine maintenance. Yard debris shall be placed in neat piles at curbside adjacent to owner's property or at the property line nearest the street with the following limitations:

- a. Materials are not to be placed on an adjoining lot whether vacant or otherwise.
- b. Leaves, pine straw, pampas and grass clippings, small shrubbery clippings, etc., must be placed in sturdy bags or other suitable containers. Such loose material placed at the curb will not be collected.
- c. Brush, limbs, and shrubbery trimmings shall:
  1. Be no more than six inches in diameter.
  2. Be no more than five feet in length with all small limbs trimmed from larger limbs.
  3. Weigh no more than 30 pounds each.

**Corn and Black Bean Salad**

- 1 can (15 oz) whole kernel corn, drained
- 1 can (15 oz) black beans, rinsed and drained
- 2 large tomatoes finely chopped
- 1 red onion finely chopped
- ¼ cup fresh chopped cilantro
- 2 garlic cloves minced
- 2 Tbsp sugar
- 2 Tbsp white vinegar
- 2 Tbsp canola oil
- 1-1/2 tsp lime juice
- ¼ tsp salt
- ¼ tsp ground cumin
- ¼ tsp pepper

**MINUTES**

**February 9, 2017**

**REGULAR COUNCIL MEETING**

**6:00 P.M.**

Present: Jane S. Darby, Mayor, Susan Hornsby, Mayor Pro Tempore, Jerome Kizer, and Crawford Moore, Council Members; *Quorum of Council Present*. Absent: Patti Smyer.

Mayor Darby called the meeting to order and Councilman Kizer led those in attendance in an invocation and the Pledge of Allegiance. Mayor Darby commented, "Let the minutes show that Councilwoman Smyer has an excused absence. Her husband is facing surgery in a hospital in Columbia tomorrow."

**Approval of Minutes**

Councilman Moore moved to approve the Public Hearing Meeting minutes of January 12, 2017, seconded by Mayor Pro Tem Hornsby and approved 4 - 0.

Councilman Kizer moved to approve the regular council meeting minutes of January 12, 2017

seconded by Councilman Moore and approved 4 – 0.

### **Old Business**

**A. Water Improvement Project – Additional Well Construction** - -On August 11, 2016, Council approved \$1,000,000 from the enterprise fund to install a new higher capacity well prior to construction of the water system improvement project. According to the Town’s financial advisor, this may impact the Town’s rerating for the revenue bond. Mayor Pro Tem Hornsby moved to withdraw this direction based on the advice of the financial advisor and fund and install the new higher capacity well as part of the water system improvement project. Councilman Moore seconded the motion which was approved 4 – 0.

### **New Business**

**A. Resolution No. 2017-R03 Adopting the American Engineering Water Rate Study** – Councilman Kizer moved to approve Resolution No. 2017-R03 Adopting the American Engineering Water Rate Study, seconded by Mayor Pro Tem Hornsby and approved 4 – 0.

**B. First Reading of Ordinance No. 2017-05 to Amend Sections 14-110(a), 14-113, 14-114(d), 14-114(h), 14-161(b)(2), 14-161(b)(5), 14-161(b)(6), 14-181(b)(1), 14-201(a), 14-221(f) and 14-221(g) of the Town of Edisto Beach Code of Ordinances regarding preliminary flood insurance study** – Councilman Moore moved to approve the first reading of Ordinance No. 2017-05 to Amend Sections 14-110(a), 14-113, 14-114(d), 14-114(h), 14-161(b)(2), 14-161(b)(5), 14-161(b)(6), 14-181(b)(1), 14-201(a), 14-221(f),14-221(g). Councilman Kizer seconded the motion, which was approved 4 – 0.

**C. Automatic Aid Agreement between the Edisto Beach Fire Department and St. Paul’s Fire District** –Mayor Pro Tem Hornsby moved to approve the automatic aid agreement between Edisto Beach and the St. Paul’s Fire District. Councilman Kizer seconded the motion, which was approved 4 – 0.

**D. Resolution No. 2017-R04 James Jamerson’s Inclusion in the SC Hall of Fame** – Councilman Moore moved to approve Resolution No. 2017-R04 recommending James Jamerson’s inclusion in the SC Hall of Fame. Mayor Pro Tem Hornsby seconded the motion, which was approved 4 – 0.

**E. Fiscal Year 2017-18 Budget Calendar** – Councilman Kizer moved to approve the FY2017-18 Budget Calendar. Mayor Pro Tem Hornsby seconded the motion, which was approved 4 – 0.

**F. Arts in the Park – Edisto Art Guild** – The Edisto Art Guild requests that the Town co-sponsor events at Bay Creek Park on June 11, July 9, and August 13 by 1) placing extra trash receptacles around the park, 2) having the restrooms cleaned and empty the trash receptacles after the event, 3) de-activating the sprinkler system on the day of the event, 4) having the park sprayed for mosquitos and fire ants and 5) waiving park fees. These performances will start at 5:00 p.m. and run 45 – 90 minutes. Mayor Pro Tem Hornsby moved to approve the Town’s co-sponsoring of the event by waiving park fees only. Councilman Moore seconded the motion, which was approved 4 – 0.

**G. Special Event Application – Edisto Chamber of Commerce – Edisto Road Race** – Councilman Moore moved to approve the application from the Edisto Chamber of Commerce to hold the Edisto Road Race on Saturday, March 18, 2017, from 8:00 a.m. – 11:00 a.m. Councilman Kizer seconded the motion which was approved 4 – 0. Road closures will take place within Wyndham only and the Fire Department will set up tables and distribute water to participants along the route.

**H. The Image and Design of Edisto Committee Recommendations for Repair and Restoration of Edisto Beach Access Areas** – The Image and Design of Edisto (TIDE) committee recommends the following to Town Council regarding beach accesses.

1. Not approve pursuing providing public showers and restroom facilities at beach access areas
2. Recommend the following policies regarding common beach access area elements and design features to restore and repair the functionality of appearance of beach access areas:
  - *Every access area should have benches, bike racks, dog waste stations, life rings, post and rope boundary delineation at every access area, access number signs at the road and beach entrances with a consistent design for location of access elements and amenities.*
  - *Repair and restore bike/ped paths and vehicle parking areas to original or improved condition with grading, compaction material and other appropriate actions.*

- *Repair and restore beach walkovers (i.e., wooden walkways elevated over dunes).*
  - *Repair and restore elements for handicapped accessibility at pre-Matthew beach access points.*
  - *Remove remains of wooden boardwalks and replace with natural dirt/sand paths for bike/ped.*
  - *Consolidate and improve signage at access areas by (1) adding "No Parking between 11 pm and 6 am" sign and "No Motorized Vehicles" to Beach Rules Signs; (2) extra signage only for "No Parking this Side" and Stop signs; (3) attaching handicapped access signs to Access Number signs at the road access points; and (4) moving Beach Rules Signs to a location that offers the best opportunity to be seen and read, e.g., at roadside entrances at vehicle access areas, or at locations where walkers and bikers enter the beach access.*
  - *Improve the appearance and functionality of trash receptacles by (1) retaining and restoring wooden trash can holders, (2) providing receptacle structures with walls on three sides, and (3) moving trash receptacles close to the road in areas easily accessible for trash disposal and removal and away from vehicle interference.*
  - *Use a common design for location of access area elements and amenities.*
- *Access #9, #10, #17, #21, #31, #35 – These are vehicle permitted beach access areas of most incidents and ticketing involving vehicles. Because incidents at these access areas have increased over the past several years, the committee will periodically consult with the Police Chief to determine if changes to access parking is needed.*

4. Recommend Schedule for Repair and Restoration – The Tide Committee Members are recommending Town Council adoption of common design elements and design layout of beach access elements and amenities that were damaged or lost as a result of Hurricane Matthew. In addition, this circumstance offers the opportunity to improve the appearance and functionality of all beach access areas. In order to support the upcoming tourist season, it is essential that repairs and restoration be completed as soon as possible, especially for areas that may not be dependent on the schedule for beach re-nourishment.

Mayor Pro Tem Hornsby moved to approve the recommendations of the TIDE Committee, seconded by Councilman Kizer and approved 4 – 0.

**I. Special Event Application – Edisto Island Ducks Unlimited** – Mayor Pro Tem Hornsby moved to approve the special event application from the Edisto Island Ducks Unlimited to hold their annual dinner on March 4, 2017, from 6:00 p.m. to 11:00 p.m. Councilman Kizer seconded the motion, which was approved 4 – 0.

### Planning Commission

**A. Meg Hoyle – Botany Bay Ecotours – Boat Tours** – Meg Hoyle requests approval to expand her business by increasing the guest number from 6 to 12 and adding a second boat, but both boats will not be in operation at the same time. This was unanimously approved by the Planning Commission. Councilman Kizer moved to approve the recommendation, seconded by Mayor Pro Tem Hornsby and approved 4 – 0.

### 3. Recommend Individual Access Restoration and Repair

- *Access #1 – Beach Access parking is adjacent to Finn's parking. Ensure 50' access is maintained and ensure beach access parking is visually distinctive and maximizes traffic flow.*
- *Access #1A – Restore all common elements for bike/ped access and put in appropriate plantings for preserving dunes and natural vegetation along the access path.*
- *Access #2- #7 – Repair or restore all common elements for bike/ped access. Move Beach Rules signs to the street side, and attach or add "No Motor Vehicles" to the Beach Rules signs.*
