SEMI ANNUAL UTILITY BILLING

The semi-annual utility billing for water, sewer, and garbage will be mailed out the first week in December. This billing is for service from December 1, 2013 through May 31, 2014.

Utility Payment Options for the Town of Edisto Beach

Residents of Edisto Beach have an option to pay their utility bills on a more frequent basis than every six months. Often this helps when trying to budget limited funds. When payments are received, the utilities department will post your payment to your account as a credit. When the utility bills are issued

in December and June, any amounts prepaid will be credited to your account and your bill will be adjusted to show any remaining amount owed. To help you figure out what amount to pay, we have broken the base rate down to a monthly rate for water, sewer and garbage. If you use more water than the base amount, your bill will be adjusted every six months based on the actual meter reading. Additional garbage cans can be added to the total monthly cost at a rate of \$4.60 per month. If a resident wants to pay the utility bill in monthly installments, and typically uses less than 24,000 gallons of water, the payment would be \$68.18 a month.

New Sidewalks on Edisto Beach!

Folks may have noticed new sidewalks and drainage construction on Palmetto Boulevard. All of this work is being paid for with grant funds and no Town funds are being used! The Town of Edisto Beach was awarded a Transportation Enhancement Grant of \$400,000 and Colleton Transportation Commission "C" funds of \$321,165 for a total project cost of \$721,165. Drainage problems to be addressed are on Palmetto Boulevard at Dawhoo Street, Cupid Street, and the 500-600 block of Palmetto.

MINUTES
October 10, 2013
REGULAR COUNCIL MEETING
6:00 P.M.

Present: Burley L. Lyons, Mayor, Larry "Babe" Hutto, Mayor Pro Tempore, Pete Anderson, Tommy Mann and Jane S. Darby, Council Members; *Quorum of Council Present.*

Mayor Lyons welcomed guests and thanked all who served the Town of Edisto Beach.

Council Session opened with a word of prayer by Councilwoman Darby who also led those present in the *Pledge of Allegiance*.

Mayor Lyons introduced Jim Rozier from the Department of Transportation and Commissioner for the Edisto Beach district. Mr. Rozier came to Edisto at the request of Councilman Mann to look at the Myrtle Street Extension. He agreed that it needs to be paved, and told Council he would encourage the DOT to have it done.

Approval of Minutes

Councilwoman Darby moved to approve the Regular Council Meeting Minutes of September 12, 2013. Councilman Hutto seconded the motion, which carried unanimously.

Proclamations and Presentations

Councilwoman Darby moved to approve a Proclamation declaring the week of October 6 – 12 Fire Prevention Week. Councilman Anderson seconded the motion, which carried unanimously. Councilwoman Darby moved to approve the Town's participation in the Great American ShakeOut, an earthquake preparedness activity, on October 17, 2013 at 10:17 a.m. Councilman Mann seconded the motion, which passed unanimously.

Old Business

Utility Billing Policy – On August 29, 2013, Council asked Administration to provide a written policy for monthly utility billing. Two issues would have to be addressed to migrate to monthly billing. First, the Town's accounting program is not capable of utilizing two billing schedules, so billing would need to be monthly or semiannually. Secondly, if monthly billing is chosen, the due date of the bill would need to be revised and the ordinance amended. Administration recommended maintaining semiannual billing and providing information to residents who would like pay monthly. Councilman Mann moved to keep the utility billing schedule on a semi-annual basis. Councilman Hutto seconded the motion, which was passed unanimously.

Fire Truck purchase – Through the budget process, Council approved the purchase of a fire truck to replace the pumper truck (1401) housed at Colleton County Fire and Rescue Station 12. Pumper 1401 will be sold or traded, whatever generates the most revenue. Purchase of the replacement pumper will be procured by sealed bid according to Section 2-206 of the Town's Code. Specifications of the new truck include a smaller wheel base and turning radius to allow better access in limited access areas. Councilwoman Darby moved to approve the purchase of the fire truck as specified. Councilman Hutto seconded the motion. Councilman Mann reiterated his position that the new truck be one that can be serviced in the immediate vicinity. Mayor Lyons called for a vote, and the motion passed unanimously.

Our Town Grant Application Clarification – The Edisto Art Guild, represented by Mrs. Cheryl Van Metre addressed Council concerning the Our Town Grant. Mrs. Van Metre asked that the Town partner with the Art Guild for the National Endowment of the Arts (NEA) Grant and requested the following: that the Art Guild Board have input into the content of the Grant; that the work already done by the Stage Committee (Tom McDonald, Dee Moseley, Virginia Woodhead, John Roberts and Cheryl Van Metre) be included in the information to the architect; and that someone from the Stage Committee have a conversation with the architect that is chosen for the project. The Grant is limited to the design of the stage.

New Business

Ordinance 2013-12 to Amend 18-53(d)(2)(c) of the Mobile Vending Ordinance and amend Section 19-53(m) to

provide for extension of the sunset provisions – Ginger Hodge, Owner of the Happie Truck, requests Council consider allowing vendors to utilize one of the remaining permits and extend the hours of operation. Councilman Anderson moved to approve the first reading of Ordinance 2013-12 to allow vendors to utilize more than one permit if not being used, extend the hours of operation and extend the sunset provision to December 31, 2014. Councilman Hutto seconded the motion, which was unanimously approved.

Fall Festival Special Event Application – The Chamber of Commerce has submitted a special event application for the 9th Annual Fall Festival on October 19, 2013 from 10 a.m. to 4 p.m. on Jungle Road in front of Palmetto Plaza. Jungle Road will be closed from 7:00 a.m. to 6 p.m. Councilwoman Darby moved to approve the application. Councilman Mann seconded the motion, which passed unanimously.

Army Corps of Engineers Edisto Beach Storm Damage Reduction Study Funding – The ACOE has requested an additional \$25,000 in funding to increase the Benefit Cost Ratio (BCR) and to assess comments, develop and provide defensible responses. The BCR weighs heavily in gaining federal funding. Originally, \$875,000 was funded by Council in 2007. The Town has spent \$788,074 and received credit for \$86,926 in "in-kind" services for a total project cost of \$875,000. "In-kind" credits are provided for services funded by the Town such as data from Coastal Science Engineers and staff time. The Local Accommodations Fund currently has a balance of \$529,276. Councilwoman Darby moved to approve funding another \$25,000 from the Local Accommodations Fund for a new contract amount of \$900,000. Councilman Hutto seconded the motion. Councilman Mann reiterated his displeasure with having to fund another \$25,000 that had already, in essence, been paid for. Mayor Lyons called for a vote and the motion passed unanimously.

Committees

There is still one opening on the Municipal Elections Commission.

Planning Commission

1401 Jungle Road – Mr. William M. Rogers – Property Line Abandonment – Mr. Rogers made application to the Planning Commission to abandon the existing lot line Lot E, Block 32 and Lot A, Block 35 located in the R1 District. Per Section 71-44 of the Town's Code, this requires Planning Commission review and Town Council

approval. This item was approved unanimously by the Planning Commission. Councilman Hutto moved to approve the lot line abandonment. Councilman Anderson seconded the motion, which passed unanimously.

1113 Nancy Street – Mr. Fleet McClamrock – Property Line Abandonment – Mr. H. Wayne Unger, Jr. representing Mr. McClamrock has made application to the Planning Commission to adjust the existing lot line Lot D, Block 28 and Lot C, Block 28, located in the R1 District. Per Section 71-44 of the Town’s Code, this requires Planning Commission review and Town Council approval. This item was unanimously approved by the Planning Commission. Councilman Mann moved to approve the adjustment of the property line. Councilman Hutto seconded the motion, which was approved unanimously.

The Utilities Department completed the annual lab quality control proficiency testing to maintain lab certification for PH and chlorine and passed both tests. The Department is now fully staffed with the hiring of two employees, Joe Rafalowski and Patrick Zemp. After their six-month probation period, they will be attending school for licensing. Quinn McCollum recently completed Biological Wastewater training and will have his "D" wastewater license after taking the test.

Chamber of Commerce

Dan Carter, Executive Director, gave the Chamber of Commerce Report:

- The Shrimp Fest was successful with an estimated 3,000 people in attendance. 472 entries were received for the kayak that was given away. From those entries, 91.95% spent the night at Edisto, 41.4% came to Edisto specifically for the Shrimp Fest, 50.64% were from SC but not from Edisto Beach and 13.35% were from North Carolina.

Public Comment Period

Tom Tindall shared some of his thoughts on change at Edisto Beach. Mr. Tindall has been coming to Edisto for 50 years. In the days before World War II, there was no electricity, and water was obtained from a pitcher pump. In the early 1970s, a neighboring house caught fire, and the Tindall home on Palmetto Boulevard was in danger of catching fire as well. Since there was no fire department, the Mayor at the time, Marion Whaley, Sr., climbed on to the roof of the Tindall home with a garden house to keep the fire from destroying the house. Mr. Tindall thanked Council for allowing him to give a brief historical perspective of change at Edisto.

Adjournment

Councilman Hutto moved to adjourn the meeting. Councilman Mann seconded the motion, which passed unanimously.
