**Call to Order**

**Approval of Minutes**

Ms. White made a motion to approve the minutes of February 5 2025, with the following change under the Town Administrator Update portion of the minutes:

**Town Administrator Updates**

Mr. Aakhus reported on the following items:

- Regarding the blue reflectors on SCDOT roads in town, the Fire Department will replace these, not SCDOT.
- New beach access signage should arrive by early April.
- Gravel has been placed at the Civic Center, Bay Creek Park, and Jungle Road Park.
- The Town shared information from the Edisto Island Open Land Trust regarding septic tank awareness.

**New Business/General Discussion**

- A. Update on KEB Activities (Chair Cantrell and Mrs. Daise)
  - Island-wide clean-up is scheduled for March 22.
  - KEB has forwarded flyers and information throughout the Town and Island; the Town placed the flyer in the March Monthly Highlights.
  - The KEB website still needs some work, but it is improving.
- B. Recycling Program
  - Mr. Cantrell asked about the Town's recycling program and if it is keeping up with the amount received. Mr. Aakhus noted the Town is not aware of any issues and all seems to be running as it should.
  - Recycling clean-outs were also suggested, and Mr. Aakhus noted perhaps the Town can offer ½ a dumpster for one day but will need to see about this.

C. Shred Event

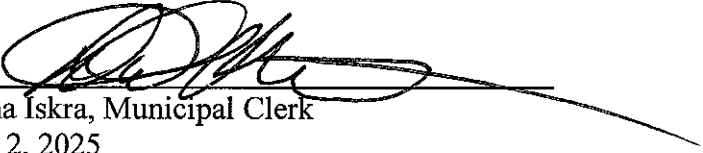
- Mrs. Iskra has taken care of all details for the Shred Event, which is confirmed for April 26, from 9:00 am – 2:00 pm.
