TOWN OF EDISTO BEACH

AN ORDINANCE

To amend Sections 86-135 and 86-142 to establish "Public parks" as a permitted use in the R-1 and PB zoning districts and to repeal Ordinance No. 09-04 to remove from Article IV Division 2 of Chapter 86 of the Code of Ordinances "government owned or operated parks and open air markets situated thereon and government owned or operated open space recreational areas" as permitted uses in all districts.

WHEREAS, prior to adoption of this ordinance the language was approved by the planning commission and a public hearing was duly held.

BE IT ORDAINED by the Town Council of the Town of Edisto Beach in Council duly assembled and by the authority of the same that:

1. Sections 86-135 and 86-142 of the Town's Code of Ordinances are amended to establish "Public parks" as a permitted use in the R-1 and PB zoning districts; and
2. Ordinance No. 09-04 is hereby repealed to remove from Article IV Division 2 of Chapter 86 of the Code of Ordinances of the Town of Edisto Beach, "Government owned or operated parks and open air markets situated thereon and government owned or operated open space recreational areas" as permitted uses in all districts.
3. This ordinance shall take effect upon adoption by Council.
